Sealed bids will be received by the City of Miami, Office of the City Clerk, City Hall, 1st Floor, 3500 Pan American Drive, Miami, Florida 33133-5504 for:

North Spring Garden Greenway Improvements

Bids Due: Friday, September 17, 2010 @ 2:00 P.M.

Scope of Work: The Work consists of furnishing all materials, labor, and equipment necessary to Reconstruct North River Drive from NW 11th Place to NW 7th Street Road to meet current criteria and standards. The project encompasses new curb and gutter, new sidewalk to meet current ADA standards, driveway reconstruction, a new drainage system, relocation/adjustment of utilities, new landscape and hardscape features to satisfy Miami River Greenway requirements, new signing and pavement markings, and a new lighting system.

CIP has scheduled a non-mandatory pre-bid conference which will be held at the following date, time and location:

Minimum Requirements: Prospective Bidders shall hold a current certified license as a General Contractor from the State of Florida and must have a minimum of five (5) years experience under its current business name, in the construction of similar projects supported by references for five (5) projects of similar size, scope, and complexity completed within the past five (5) years. The Bidder must self-perform at least thirty percent (30%) of the physical construction work. Electrical sub-contractor for the lighting system must be certified by FP&L.
