

**Black Beard's Beach**  
**at the City of Miami's Graepeland Water Park**

- **ADMISSION** is based on capacity limits of the Water Park and will be up to management's discretion to allow patrons inside the facility. Capacity may vary based on the water attractions that are open. **ALL GUESTS** 17 years old or younger **MUST** be accompanied by and adult 21 years old or older. Supervision ratio of a minimum of one (1) adult for every eight (8) youths is strictly adhered to.

**ADMISSION FEES**

- Children under 3 are **Free**
  - Children 4 – 13 years of age **\$5**
  - Patrons 14 years of age and older **\$12**
  - Patrons 14 years of age and older (Dade County Residents w/ photo ID) **\$10**
- **PROPER ATTIRE** is required. Approved (No metal or zippers) SWIM suits/trunks are required in all pools. No jean shorts, cut-offs, basketball shorts, thongs or clothing with rude, vulgar or offensive language or graphics. Water Park admission may be denied if clothing is deemed by management to be inappropriate.
  - **NO FOOD, BEVERAGES OR COOLERS** may be brought into the Water Park.
  - **NO RE-ENTRY** is allowed. Once you exit the park you must re-purchase an admission ticket to enter.
  - **NO SMOKING** - Grapeland Water Park is a smoke-free facility and smoking is strictly prohibited.
  - **BEHAVIOR** – All guests are expected to behave in a family-friendly manner. Profanity and/or unruly behavior are offensive and will result in the removal of the offending individual(s) from the Water Park without refund.
  - **PROHIBITED ITEMS** include but are not limited to: lawn/folding chairs, floatation devices, toys, spray paint, aerosol cans, markers, glass bottles, weapons (including mace and pepper spray), explosives, and any other item deemed inappropriate by management.
  - **BAGS, BACKPACKS** and all carry-in items are subject to inspection prior to entering the Water Park.
  - **PETS** are not permitted in the Water Park.
  - **BY ENTERING** the park, each guest grants Grapeland Water Park and the City of Miami the right to film, videotape, or photograph him/her on park property for any reason without payment or consideration.
  - **ALL DECKS AND POOLS** at Grapeland Water Park are handicap accessible.
  - **ANNUAL PASS** holders must present their pass with a photo ID to gain entrance to the Grapeland Water Park.
  - **CAMERAS** are not allowed in any of wet areas.
  - **PARTY RENTALS** are not allowed during the months of June, July nor August due to our capacity during peak season.

**LIGHTNING AND INCLEMENT WEATHER POLICY**

**Grapeland Water Park has a Thor Guard lightning prediction system.**

In the event of lightning conditions you will hear a 15 second horn blast. At this time you **MUST** immediately clear all areas of the Water Park and return to your vehicles. The Water Park will be closed. Please adhere to all instructions from the Lifeguards and Water Park staff.

**ALWAYS KEEP YOUR RECEIPT** - In the event of lightning and inclement weather, all patrons **MUST** leave the park immediately. Receipt will serve as a rain check and will be valid for a one time only admission to the Water Park. If your receipt is lost or missing, no re-entry or rain checks will be permitted.
